# Apprentice Qualities required to succeed Triple A: Aspiration Attitude Achievement

# The Definition of an Apprenticeship

An Apprenticeship is a job that requires substantial and sustained training leading to the achievement of the apprenticeship standard and the development of transferable skills.

This definition is underpinned by four principles of future Apprenticeships.

- An Apprenticeship is a job, in a skilled occupation.
- An Apprenticeship requires substantial and sustained training lasting a minimum of 12 months, normally 2-2.5 years, including 20% off-the-job training.
- An Apprenticeship leads to full competency in an acceptation demonstrated by the achievement of an Apprenticeship standard that is defined by Employers and Apprentices.
- An Apprenticeship develops transferable skills, including English and Maths (where needed) customer service skills, communication, personal development and confidence, as well as time keeping, team work and the correct attitudes and behaviours in the work place.





# Which Hairdressing Apprenticeships are available at The Hair Academy?

Here at The Hair Academy, we offer a fun and varied curriculum designed for people aged 16 – 24. The Level 2 is the Intermediate Apprenticeship (IA) and the Level 3 is the Advanced Apprenticeship (AA). These Apprenticeships are government funded and are available to young people looking for work-based learning. This allows them to earn whilst they learn, the duration of an Apprenticeship is on average two years, but this will be agreed with you and The Hair Academy during the Induction Process.

# The Intermediate Apprenticeships in Hairdressing Level 2 Hair Professional Standard

#### **Hairdressing Standard Units**

This is a <u>National Vocational Qualification (NVQ) Level 2 in Hairdressing</u>. This Apprenticeship will cover 6 subject areas. These include Consultation, Shampoo and condition, Cutting, Styling and dressing hair, Perming and Colouring. Math's & English (if needed) Values, behaviors and attitude, 20% off the job training in salon and an end point assessment

Once they are qualified to a Level 2, they would have developed the skills to work within a salon as well as gaining many employability skills.

To be eligible for this course they must have a contract of employment and be working in a salon on a full-time basis. Minimum of 30 hours a week and be paid the minimum wage for their age.

Training is 1 day a week at the hair academy Training day will be discussed with you

# The Advanced & Creative Hair Professional Apprenticeship Standard in Level 3 hairdressing

This is a National Vocational Qualification (NVQ) Level 3 in Hairdressing. This Apprenticeship will cover six subject areas. Some of these areas are Advanced Cutting & Styling techniques, promotional activities, color conversion methods, smoothing & straightening as well as photographic and hair collections.

This qualification will enable them to work in a salon at a **Supervisory/senior Level**.

To be eligible for this course the learner must have completed an NVQ Level 2 in Hairdressing or equivalent experience, be working under a contract of employment in a salon on a full-time basis

Training is 1 day a week at the hair academy, training day will be discussed with you.





#### Level 2 Diploma for Hair Professionals in Barbering

This qualification will take place at The Hair Academy on a weekly basis with our Barbering Tutors. The training day is a Wednesday and there are two routes either the barbering unit route-suitable for those learners that have completed a level 2 in hairdressing- each unit takes 6 weeks to complete and you can choose from the below units.

Or you have the full NVQ for those with no prior experience in hairdressing/barbering

This qualification covers six subject areas to include Consultation, shampooing, Cutting using barbering techniques, styling & finishing men's hair, cut facial hair, provide shaving services.

Level 2 hairdressing/barbering standard includes Functional Skills Math's and English (if needed) and values and behaviors. 20% off the job training in salon and an end point assessment test

To be eligible for this course they must have a contract of employment and be working in a salon on a full-time basis 30 hours a week and be paid the minimum wage for their age or above.

# What is The Hair Academy / Employer/ Leaner's Agreement?

Our Learner's Agreement is a contract between The Hair Academy, the Employer and the Learner. Everyone involved will sign to agree their roles and responsibilities in regard to the apprenticeship. Employer will be issued with a **Definition of a Quality Apprenticeship Agreement**. This document indentifies the employer's responsibilities to the learner during their time of employment on their Apprenticeship.

You are responsible for covering and supporting with the following,

Covering Safeguarding, Equal Opportunity Provisions, Work hours and Annual Leave, Training Nights, Salon Code of Conduct, Working Time Regulations / Minimum Wage, Sickness Absence and Sick Pay, Employee Rights – Contract of Employment, Organisations within Hairdressing, Health and Safety, Grievance Procedure, Disciplinary Procedure and Advice, Issue of Public Concern, Career Pathways and Progression Routes and Advice and Maternity Rights & Pay. 20% off the job training in salon (6 hours per week)





## What do I have to pay an Apprentice?

Apprentices are exempt from the minimal wage for the first year of training. An apprentice currently must be paid £6.40 per hour (from April 24) however, this is usually revised every April. (Please visit www.gov.uk for more information & guidance) Many Employers choose to pay more than the hourly rate in recognition of the learner's hard work and commitment to the company. Alternatively, you can visit www.gov.uk online and that will have the latest National minimum wage information and guidance on Employing an Apprentice.

## Is there any help to employ an apprentice?

The Government offer an incentive payment for learners on the new hairdressing Standard of £1000, this is paid over two payments at start up (after 3 months and after 12 months) Please contact us for up-to-date information on this.

## What does the learner need to bring when they start their Apprenticeship?

All of the equipment is required from all Apprentices before starting.

The Hair Academy will supply a complimentary lanyard that must be worn at all times whilst at The Hair Academy. If this gets lost, a replacement cost will be included.

# How will I know how my learner is progressing?

The Hair Academy will send you a formal 3 monthly up to date training plan stating what the learner has been working on in training sessions and what they have achieved. These are colour coded red-not started, amber-in progress and green-completed and also give guidance and targets for the learner/tutor to follow. Your learner's progress is at the heart of all our decisions therefore it is vital that we maintain effective communication. All learners have an e-portfolio system so you will be able to access your learners on line portfolio 24/7 to see progress to date.



## Can I attend the academy to see how my learner is doing?

You can visit us at any time to observe your learner in training, no appointment necessary. We are more than happy to hold meetings in person throughout the year to provide you with updates on changes that may affect Apprenticeships, (this information will also be sent via email and newsletters) as well and provide you with an opportunity to meet with our tutors and discuss your learner progress; we welcome your views and invite your opinions on how we may improve our service offer to further develop our training programmes. ## Can I assess my learner in the work place?

Yes, we encourage employers and in-house assessors to participate in the learning process. You may record your learner's progress in the formative logbook and if you hold an Assessor Award you may also conduct summative assessment which may be recorded in your learners E portfolio. Assessors that conduct summative assessment must comply with the City and Guilds quality assurance procedures and attend at least two annual standardisation meetings and provide evidence of the required hours of continuous personal development (CPD) per year. Tutors are also subject to quality assurance visit from internal and external verifiers.

## Are there any costs that I have to pay?

A Level 2 apprenticeship age16-18 has no employer costs it is 100% Government funded.

Employers have to open an apprenticeship service account to secure funding for the apprentice and select the provider they wish to place their apprentice with.

# Please note that any learners over the age of 19 will attract a 5% employer contribution to training, this covers both the Level 2 and Level 3 qualifications
